“Changing Realities of Migration and Asylum”

Stockholm, 15 November 2018

This European Migration Network Conference aims at identifying recent trends and changing patterns of migration and asylum in the EU from a comparative perspective. It asks what has changed since 2015, and how new migratory trends relate to the various legal and policy changes in the Member States and at EU level that were introduced in response to the crisis three years ago.

The topic of the conference is linked to two topical EMN studies – the 2017/2018 study on the changing influx of asylum seekers and the 2018 study on the impacts of visa liberalization.
