


#### National structure

- Ministry of Justice
  - Responsible for processing of asylum claims.
- Ministry of Social Affairs and Labours
  - Responsible for the service for asylum applicants
    - Housing, health care, allowance ect.
      - The Directorate of Labour from July 1st 2022.
- Burden sharing






## Act on foreigners no. 80/2016

- Iceland is not bound by the EU temporary protection directive.

- Implemented for the first time since the act entered into force January 1st 2017.
  - Valid to 2nd of March 2023.
- This article covers the same groups as determined in the EU directive.



## Act on foreigner no. 80/2016

- A residence permit is granted on humanitarian grounds for one year at a time, with the possibility to renew or extend if for ut to three years from the time a permit was first issued.
- After that time a permit may be issued that can become the basis for a permanent residence permit.
- Conditional access to Icelandic labour market, which is based on the requirement that an employer must apply for work permit for the person in question.
  - There is a bill at the Parliament aiming to change this and make it automatic with the residence permit.

## The process

- Pre-registration form online: <a href="https://www.firstmedical.is/en/">https://www.firstmedical.is/en/</a>
  - Linked to police database and Directorate of Health database
  - This is not an actual registration of an asylum claim.
  - Information regarding identidy
  - Information regarding health for better process of First medical check
- Also an indicator on how many asylum seekers are to be expected.



## The process

- Few entry points to Iceland
  - Keflavík airport
  - The harbour in Seyðisfjörður
- Easy to controle the flow of people to the country and into the process of their asylum claim.
- Special attention payed to possible trafficking victims and children without their legal guardian.
  - Police staff and Immigration staff



## Challanges

#### Housing

- All asylumseekers have the right to stay for 2 weeks in housing provided by the Directorate of Immigration/Labour after receiving their residence permit on the grounds of their asylum claim.
- After that the municipalities are responisble for housing.

#### Municipalities

- There is no quota system in our law regarding burden sharing between municipalities.
- Individual contract with the municipalities are in the making as we speak.
